2016 HONG KONG INTERNATIONAL TOUR

IT IS IMPORTANT THAT YOU READ AND UNDERSTAND THE FOLLOWING CONDITIONS BEFORE MAKING YOUR BOOKING.

THE 2016 HONG KONG INTERNATIONAL TOUR is a project of World Racing Tours Pty Ltd and South Melbourne Travel Pty Ltd. This Tour is ground content only.

1. RESERVATIONS AND DEPOSITS: Places for this tour are limited. Deposit of \$1000.00pp is due within 7 days of registration completion. Final Payment is due 90 days prior to departure.

2. PAYMENTS: The following payment schedule applies to all bookings made. Should payments not be received by the nominated date, reservations will be automatically cancelled without notice.

3. METHODS OF PAYMENT: All payments must be made in Australian Dollars; payment in any other currency will not be accepted.

- Credit Card: World Racing Tours and South Melbourne Travel accept Visa/MasterCard/Amex and Diners. Credit Card Processing fees apply to each payment as follows: Visa/MasterCard 2.0% surcharge, American Express & Diners: 3.8% surcharge. The fee will be added to the amount due on your invoice. Should you decide to pay by credit card you will be required to return a signed invoice authorising South Melbourne Travel Pty Ltd to charge your nominated card.
- Direct Deposit: account details will be provided with your booking confirmation

4. CANCELLATION OF BOOKING: A cancellation fee will be applied as follows:

- a. Initial deposit is non refundable
- b. *Cancellations made 90 days or more prior to departure will incur loss of deposit.
- c. Cancellations received 70-45 days prior to departure will incur loss of 50% of tour price.
- d. Cancellations received less than 45 days prior to departure - 100% cancellation penalty applies

5. ALTERATION TO TOUR PRICES: The tour pricing is based on available pricing at the time of printing and are subject to change. Any currency fluctuations prior to departure or the cost of any amendments to the itinerary necessitated by unforeseen circumstances must be borne by the passenger(s). Should this be unacceptable the passengers reserve the right to cancel bookings held subject to the cancellation clauses detailed in Clause 4.

6. ITINERARIES AND SCHEDULES: The tour is based on published airline schedules, current at the time of printing, which are subject to change without notice.

7. PASSPORT AND VISA REQUIREMENTS: Kindly note that passport and visa requirements are not the responsibility of World Racing Tours or South Melbourne Travel Pty Ltd responsibility, and are not liable for any loss of expense due to a passenger's failure to comply with the above.

Each person requires a valid passport. Passports must have at least 6 months validity from the date of return to Australia. For up to date advice on visas required for overseas travel, Australians should contact the nearest embassy or consulate of the country they intend to visit well in advance of travel. Visas may take several weeks to process.

8. TOUR DURATION: The duration of the 2016 Hong Kong Internatioanl Tour is 7 days / 6 nights as specified in the itinerary. The duration is subject to change if deemed prudent by the organisers.

9. COSTS NOT INCLUDED: Cost of passports or visas, meals and sightseeing other than those specified in the itinerary, gratuities/tips (unless stated), excess baggage charges, personal items such as phone calls, laundry, insurance are not included in the World Racing Tours Pty Ltd packages.

10. TOUR FARE INCLUDES:

- a) Hotel Accommodation: The Peninsula Hotel, Hong Kong as specified in the itinerary, based on two people sharing a twin room. A single room supplement is available.
- b) Meals: Breakfast will be included each day plus other meals and functions as specified in the itinerary.
- c) Flights must be arranged by the traveller. South Melbourne Travel can assist.

11. ENTRANCE FEES: All entrance fees to venues specified in the package, relevant charges and government charges including airport taxes, are included in the package fare.

12. TRAVEL INSURANCE: It is conditional that at the time of booking you complete an application for travel insurance or sign an indemnity form declining to accept the travel insurance offered. The policy you choose should include: Loss of deposit through cancellation, loss of personal baggage and money, medical expenses and additional expenses to cover the curtailment of your tour whilst overseas. South Melbourne Travel Pty Ltd can assist you in obtaining the right cover for this tour.

13. RESPONSIBILITY: World Racing Tours, South Melbourne Travel Pty Ltd and/or their associated companies or Agents give notice that they act as organisers and Booking Agents only for the persons or companies providing or offering the means of travel conveyance, transport, accommodation or other services and all receipts, dockets, vouchers, coupons or exchange orders are issued subject to the terms and conditions under which transportation and other services are provided. Neither World Racing Tours nor South Melbourne Travel Pty Ltd shall be liable for any injury, damage, loss, accident, delay or irregularity that may be caused to person or property however caused or arising during the tour.

14. PROGRAM MODIFICATION: The right is reserved to modify the itinerary in any way considered necessary or desirable or to change

any reservation and/or means of conveyance, without notice and for any reasons whatsoever and without allowance or refund but the extra cost, if any, resulting there from must be paid by the passenger. The right is also reserved to cancel or withdraw any tour or booking made for a passenger or decline to accept or retain any person as a member of the tour for any reason whatsoever.

15. NON PARTICIPATION: No refund can be made in respect of accommodation and meals not utilised and under no circumstances can refunds be made for tours and sightseeing excursions not undertaken.

16. LIABILITY: The transportation companies or firms shall be exempt from all liability in respect of any detention, delay, loss, damage, sickness, or injury, however, and by whomever caused, and of whatever kind occurring of or to the passenger at any time when the passenger is not on board a carrier or conveyance used or operated by the transportation companies or firms. Passenger contracts in use by the transportation companies or firms concerned shall constitute the sole contract between the transportation companies or firms and the purchaser of the tours and/or passengers.

17. FARE AMENDMENTS: All fares are subject to change without notice, and the organiser reserves the right to amend the land package cost of the tour in the event of foreign currency fluctuations. Should any additional charge be involved, this will be advised and billed to the passenger prior to departure.
